SR 836/Dolphin Expressway

Ramp Closure

Southbound Florida's Turnpike to eastbound SR 836/Dolphin Expressway will be closed for ramp construction from Monday, July 29 through Wednesday, July 31 from **10 p.m. to 5:30 a.m.** **Drivers should follow all posted detour signs. Detour information:**

- Take exit to NW 12th Street
- Turn left to eastbound NW 12th Street and continue
- Turn right to NW 107th Avenue and drive south
- Take entrance to eastbound SR 836 on the right

The following closures are part of the I-395/SR 836/I-95 Design-Build Project. This schedule may change due to bad weather or other unforeseen conditions.

WEDNESDAY MORNING, JULY 31 – A new traffic pattern will be implemented on westbound MacArthur Causeway just west of Watson Island and on the ramp to SR 5/US 1/Biscayne boulevard (Exit 2). The merge on the right lane, just west of Watson Island, will be removed and **the exit to SR 5/US 1/ Biscayne Boulevard will be moved approximately one-quarter of a mile further to the east as shown below.** The exit only lane on the right will be separated with temporary concrete barrier wall from the three lanes to the left that will continue west. Signs, electronic message boards and markings on the pavement will indicate that the right lane is for exiting traffic only and the three left lanes are for those drivers wanting to continue west. The three lanes continuing west will merge to two lanes east of Biscayne Boulevard and continue west of I-395.

The closures noted below will be implemented to continue the construction of the overhead bridge support structure on eastbound SR 836 just west of I-95.

TUESDAY, JULY 30 AND WEDESDAY, JULY 31 – All eastbound travel lanes on I-395 at I-95 and the eastbound SR 836 ramp to southbound I-95 will be closed between the hours of **10 p.m. and 5:30 a.m.**

Drivers can:

- Enter the northbound I-95 ramp and continue north
- Exit at NW 62nd Street and turn left to access the southbound I-95 ramp
- Drivers heading to eastbound I-395 can use exit 2D

FRIDAY, AUGUST 2 – All eastbound travel lanes on I-395 at I-95 and the eastbound SR 836 ramp to northbound I-95 will be closed between the hours of **10 p.m. and 5:30 a.m.**

Drivers heading to eastbound I-395 can:

- Access the southbound I-95 ramp
- Exit at SW 7th Street/Brickell Avenue (Exit 1B), then turn left at SW 8th Street
- Enter the northbound I-95 ramp, then access the ramp to eastbound I-395

Drivers heading north on I-95 can:

- Access the southbound I-95/NW 8th Street ramp, then exit at the NW 8th Street/PortMiami ramp
- Turn left at NW 8th Street
- Turn left at NW 3rd Avenue to access the northbound I-95 ramp

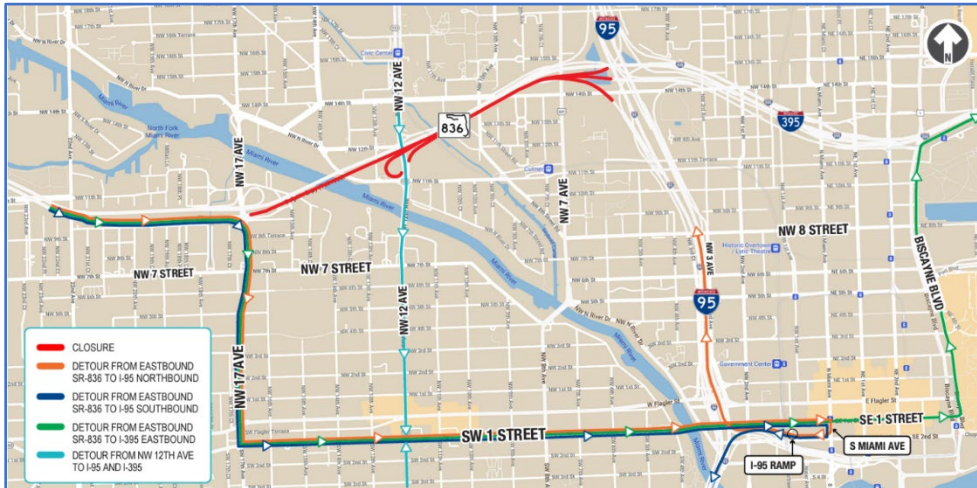
Complete closures of eastbound SR 836 continue from NW 17th Avenue to I-95, as noted below, to safely construct a bridge support structure that will span the entire width of eastbound SR 836 just west of I-95.

Monday, July 29 and Thursday, August 1 between the hours of 10 p.m. and 5:30 a.m.

The detours noted below will be in place to guide drivers around the work area. Drivers on eastbound SR 836 will:

- Exit at NW 17th Avenue, then continue south across NW 7th Street
- Turn left at SW 1st Street and continue east
- Turn right at South Miami Avenue
- Turn right to access the ramp to I-95 north or south
- Drivers going to Biscayne Boulevard and the MacArthur Causeway can continue east on SW 1st Street and turn left on Biscayne Boulevard to connect with the MacArthur Causeway entrance ramp at NE 11th Terrace

Drivers on NW 12th Avenue wanting to access eastbound SR 836, I-95, Biscayne Boulevard, and the MacArthur Causeway can continue south on NW 12th Avenue, turn left at SW 1st Street, and follow the detours above.



MONDAY, JULY 29 AND THURSDAY, AUGUST 1 – All westbound lanes on SR 836 will be closed from NW 12th Avenue to NW 17th Avenue between the hours of **10 p.m. and 5:30 a.m.** Tuesday, July 30 is a back-up date. Drivers can:

- Exit at the NW 12th Avenue ramp, then turn left on NW 12th Avenue
- Turn right on NW 7th Street
- Turn right on NW 27th Avenue and continue north to connect with the westbound SR 836 ramp



SUNDAY, JULY 28 THROUGH FRIDAY, AUGUST 2 – Up to two lanes on eastbound SR 836 from NW 17th Avenue to I-95 will be closed as needed between the hours of **9 p.m. and 5:30 a.m.**

SUNDAY, JULY 28 THROUGH FRIDAY, AUGUST 2– Up to two lanes on westbound SR 836 from I-95 to NW 17th Avenue will be closed as needed between the hours of **9 p.m. and 5:30 a.m.**

THURSDAY, AUGUST 1 AND FRIDAY, AUGUST 2 – The eastbound SR 836 ramp to northbound I-95 will be closed between the hours of **10 p.m. and 5:30 a.m. Drivers can:**

- Access the southbound I-95/NW 8th Street ramp, then exit at the NW 8 Street/PortMiami ramp
- Turn left at NW 8th Street
- Turn left at NW 3rd Avenue to access the northbound I-95

SUNDAY, JULY 28 – The eastbound SR 836 ramp to southbound I-95 will be closed between the hours of **9 p.m. and 5:30 a.m. Drivers can:**

- Continue east on I-395
- Exit at NE 2nd Avenue/Biscayne Boulevard (Exit 2B)
- Turn right on NE Avenue, then turn right on NE 8th Street
- Then turn left on NW 3rd Court
- Continue south on NW 3rd Court to access the I-95 south ramp after NW 2nd Street

SUNDAY, JULY 28 THROUGH THURSDAY, AUGUST 1 - NW 17th Avenue will be closed between NW 7th Street and the north side of SR 836 between the hours of **10 p.m. and 5:30 a.m.** Closure start times may vary depending on events.

Drivers on northbound NW 17 Avenue heading west on SR 836 can:

- Turn west on NW 7th Street
- Turn right on NW 27th Avenue to access the SR 836 west entrance ramp

Drivers on northbound NW 17th Avenue continuing north can:

- Turn west on NW 7th Street, then turn right on NW 22nd Avenue
- Turn right on NW 20th Street to connect with NW 17th Avenue

Drivers on southbound NW 17th Avenue continuing south can:

- Turn west on NW 20th Street, then turn left on NW 22nd Avenue
- Turn left on NW 7th Street to connect with NW 17th Avenue
